Directions For Use

CORE BEAN BOOSTER is compatible with most pesticides. A jar test is recommended.

Use the following mixing sequence:

- 1. Water:
- 2. CORE BEAN BOOSTER;
- 3. Pesticides.

Minimal agitation is required.

Recommended Rates

The optimum rate of application will vary between fields, depending on soil pH and organic matter content. For best results, follow soil test or plant analysis recommendations.

Soybeans: Apply 2 to 8 pts/ac in 10-20 gallons of water with postemergence herbicides beginning about three weeks after emergence. May be applied when first pods reach 1/4" in length.

Storage and Disposal

This product may be corrosive to aluminum, mild steel, and/or brass if not diluted. Copper or any of its alloys (brass or bronze) should never be used in any chelate handling system. Store in fiberglass, polyethylene or stainless steel containers/tanks. Check with equipment manufacturer for compatibility of components prior to use with this product. Store in cool place in original container in a storage area inaccessible to children, pets, domestic animals or wildlife. Dispose of this container in an environmentally safe manner as recommended for your area.
